**Invitation to Bid for the Purchase of One (1) Unit Service Vehicle
to be used by EOD Construction & Maintenance Personnel**

1. The *Calumpit Water District*, through the **Internal Cash Generation** intends to apply the sum of *Seven Hundred Fifteen thousand Pesos. (Php 715, 000. 00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *supply and delivery of one (1) unit service vehicle/ Contract No. 2016-012*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Calumpit Water District now invites bids for the *purchase of one (1) unit service vehicle to be used by EOD construction & maintenance personnel*. Payment shall be made upon completion of delivery of goods. Delivery of goods is **30 calendar days**. Bidders should have completed within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from *Calumpit Water District* and inspect the Bidding Documents at the address given below from **8: 00 am to 5: 00 pm**. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Five Thousand Pesos (Php 5,000.00)*.
5. The *Calumpit Water District* will hold a **Pre-Bid Conference** on **03 August 2016 @ 1: 30 p.m. at Boardroom, CWD Office Bldg., M. Serrano St., Brgy. Corazon, Calumpit, Bulacan**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before **17 August 2016 @ 1:30 p.m. at Boardroom, CWD Office Bldg., M. Serrano St., Brgy. Corazon, Calumpit, Bulacan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
7. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The Calumpit Water District reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
