- b) When the procurement of critical components from a specific supplier is a condition precedent to hold contractor to guarantee its project performance, in accordance with the provisions of its contract; or
- c) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP.

- 1. To recommend the use of Direct Contracting for Purchase Request No. 2017-01-004.
