WHEREAS, the Bids and Awards Committee is hereby instructed to act upon the CWD with Purchase Request No. 2017-03-007; Supply and Delivery of Various Fittings;

WHEREAS, the members of the BAC agreed to adopt Section 50, Article XVI of RA 9184, which states the use of Direct Contracting or single source procurement, a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with condition of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:


- a) Procurement of items of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets and copyrights prohibit others from manufacturing the same item;
- b) When the procurement of critical components from a specific supplier is a condition precedent to hold contractor to guarantee its project performance, in accordance with the provisions of its contract; or
- c) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP.


NOW THEREFORE, We, the members of Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;

1. To recommend the use of Direct Contracting for Purchase Request No. 2017-03-007.
2. To recommend for approval by the General Manager of the Calumpit Water District the foregoing findings;
