WHEREAS, the Bids and Awards Committee is hereby instructed to act upon the CWD with Purchase Request No.2022-06-011; Supply & Delivery of 100 Pieces ½" x 6m Gl Pipe (Sch.40) Std. & 20 Pieces 50mm x 6m Gl Pipes (Sch.40) Std.;

WHEREAS, the members of the BAC agreed to adopt Section 52, Article XVI of RA 9184, which states the use of <a href="Shopping">Shopping</a>, a method of procurement of goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications. This method of procurement shall be employed in any of the following cases:

- a) When there is an unforeseen contingency requiring immediate purchase: *Provided, however,* that the amount shall not exceed the thresholds prescribed in Annex "H" of this IRR.
- b) Procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding the thresholds prescribed in Annex "H" of this IRR.
