WHEREAS, Calumpit Water District (CWD) was created pursuant to PD No. 198, as amended by PD No. 768 and 1479, otherwise known as the Provincial Water Utilities Act of 1973, is amended with a vision, mission and goal of providing district residents with a safe, reliable and economically viable water service at 100% service coverage;

WHEREAS, CWD as an entity which is independent, autonomous, non-stock, self-supporting, non-profit, self-reliant, Government Owned and /or Controlled Corporation but does not receive regular subsidy, grant or budgetary allocation from any political or government subdivisions has to be vigilant and accurate in its decisions to avoid bankruptcy /or major breakdown;

WHEREAS, the proposed CWD's corporate operating budget for FY 2023 is still under review and evaluation by the management.

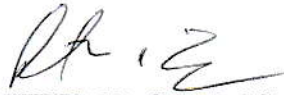
WHEREAS, the water supply service of the district must continue 24/7 without interruption;

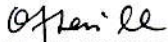
